A Will County application was filed for a special use permit. The application for the special use permit affects property located within one and a half (1 ½) miles of the Village limits therefore the County notifies the municipality and provides them the opportunity to review the application. After the process of the Plan Commission review and Village Board action the staff will convey the decision by the Village

of Elwood to be considered at the County Planning & Zoning Commission meeting on June 5, 2018, at 6:30pm and at the subsequent Will County Board meeting where Case No. ZC-18-016 will be considered.

Property owners Carol and Ken Palmer at 19954 W. Manhattan Road (property actually 19921 W. Munch Lane) are seeking a special use permit in the A-1 district to allow keeping more than 6 dogs and cats in order to operate an animal rescue.

A motion was made by Commissioner Elberson to recommend the proposed special use permit be approved by Will County with the required conditions of a maximum of 15 companion animals and the restriction of animals to being indoors from 10:00 pm to 6:00 am. The motion was seconded by and seconded by Commissioner Nagel. Commissioner Nagel seconded the motion. A vote was called: Commissioner Vaughn – yes, Commissioner Fanning – yes, Commissioner Nagel – yes, Commissioner Elberson – yes, Commissioner Meyers – yes. The motion carried.
