November 2025 Financial Reports

The Financial Report, prepared by Finance Director Robbie Day, is presented to the Village Board for review. The report represents the Village of Elwood's year-to-date revenues, expenses, and end-of-month fund cash balances.

A Resolution Authorizing a Jurisdictional Boundary Line Agreement Between the City of Joliet and the Village of Elwood

The Resolution authorizing a jurisdictional boundary line agreement between the City of Joliet and the Village of Elwood is the final piece of the puzzle in securing the Village of Elwood's borders. This is a very exciting accomplishment for the Village as it has been 9 years in the making.

As required, the Public Notice was published in the Joliet Herald Newspaper on December 5, 2025, and was also posted outside the main entrance to the Village Hall. The City of Joliet will consider the proposed Boundary Line Agreement at its City Council meeting on January 6, 2026. We thank Mayor Terry D'Arcy and the City of Joliet team for working with the Village and recognizing the importance of this agreement to the Village of Elwood.

An Ordinance Establishing an Elwood Community Days Committee

The Elwood Community Days event has continued to grow in size and participation. The planning responsibilities have also increased requiring coordinated efforts in the setup logistics, vendor management, and community engagement. The Ordinance will formally establish the purpose of the committee to serve as an advisory committee for the Corporate Authorities. The committee shall generate ideas, suggestions and make recommendations, assist in creating, planning and conducting events for Community Days. The committee shall comply with the Open Meetings Act. A motion was made by Trustee Mytnik to adopt an Ordinance Establishing an Elwood Community Days Committee. Trustee Eastman seconded the motion.
