In 2016 the Village was presented with a development opportunity for the “Northpoint Project.” The Village conducted a public hearing before the Plan Commission with respect to the annexation, zoning and a Special Use Permit for the project. Village staff and consultants then negotiated a draft annexation agreement which was scheduled for a public hearing on Monday, April 23, 2018. In anticipation of the public hearing, I have discussed this matter individually with many of the Village Trustees. My discussions have led me to conclude that there is not sufficient support for approval of the annexation agreement, therefore, I have cancelled the public hearing. It is my intention that the public hearing will not be rescheduled unless I am instructed to do so at a public meeting of the President and Board of Trustees where such a request is on the board agenda.
