# RESOLUTION FOR THE ADOPTION OF A SCHEDULE OF REGULAR MEETINGS FOR CALENDAR YEAR 2020

This resolution coming before the Village Board of Trustees of the Village of Elwood ("Corporate Authorities") for consideration at its public meeting on December 4, 2019.

WHEREAS, the Village of Elwood is a Home Rule Unit under sub-section (a) of Section 6 of Article VII of the Constitution of the State of Illinois of 1970; and

**WHEREAS**, a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare; and

WHEREAS, pursuant to 5ILCS 120/9/02, every public body is mandated to give public notice of the schedule of regular meetings at the beginning of each calendar year, including the dates, times and places of such meetings; and

WHEREAS, the public bodies for the Village of Elwood consist of the Board of Trustees, Plan Commission Finance Committee, Elwood International Port Committee and the Park and Recreation Committee

**NOW THEREFORE**, **BE IT RESOLVED** BY THE VILLAGE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ELWOOD, WILL COUNTY ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS AND STATUTORY AUTHORITY, AS FOLLOWS:

**SECTION 1: INCORPORATION** That the preambles to the Resolution be, and the same hereby are incorporated herein by this reference as it set out in full at this place.

**SECTION 2:** ADOPTION That an Official Schedule of regular meeting dates for the corporate authorities and is aforementioned commissions and/or committees (attached hereto and incorporated herewith as Exhibit "A") for 2020 is hereby adopted by the Village of Elwood.

<u>SECTION 3:</u> REPEALER All ordinances and/or resolutions approved by the Village of Elwood which are inconsistent herewith, to the extent of such inconsistency and no further, are hereby repealed upon the effective date hereof.

**SECTION 4: SEVERABILITY** Should any section, subsection or other provision of this Resolution for any reason be held invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the Resolution as a whole or any part not declared invalid.

**SECTION 5: PUBLICATION** The Village Clerk is hereby authorized and directed to publish this Resolution, by publication in pamphlet form for general distribution in the manner provided by law.

**SECTION 6: EFFECTIVE DATE** That this Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
