Rates stated above include a one-hour rehearsal prior to the ceremony date.

- ❖ All rentals are final. Fees are nonrefundable and nontransferable. Refunds are not issued based on weather conditions.
- ❖ The Children's Garden and Pavilion are available for ceremonies only. For rental and reception information, please contact the Marie Rodgers at 815-423-5011.
- ❖ On your wedding day, setup, ceremony and clean up must be complete within the period allotted to you. Please assign someone to do any decorating before the ceremony and clean up afterward.
- ❖ All ceremony arrangements, decorations, props, music (a good boom box or Ipod will work well but you are welcome to have live music), Clergy or Officiator must be provided by the Bride and Groom.
- ❖ The Children's Garden Pavilion is available for use during the ceremony. The picnic tables may be rearranged only on the concrete area of the Pavilion to allow placement of rental chairs. The tables are very heavy and require four adults to move. They must be put back into place when the ceremony is over.
- ❖ There is one electric outlet available for use during the wedding. It is located on the center of the support post located on the north side of the Pavilion.

- ❖ No rice, bird seed or balloons are permitted. We suggest bubbles instead. Smoking and alcoholic beverages are prohibited.
- ❖ The Bride and Groom are responsible for the conduct of their guests. Please read the wedding guest guidelines and inform your guest. You may consider including this information with your invitation. The Bride and Groom shall compensate the Children's Garden Project for any damage or loss of property caused by any person attending the wedding rehearsal or ceremony. In addition, the Children's Garden Project reserves the right to reduce or retain the security deposit refund if it is determined that any damage has been done to the property. Please respect the Garden.
- ❖ The Children's Garden Project is not responsible for the loss or damage to any property belonging to the Bride and Groom or their guests. This includes the time before, during or after the rehearsal and ceremony.
- ❖ The Children's Garden Project is not responsible for any injury at any time before, during or after the rehearsal and ceremony.
- ❖ Bride and Groom agree to be bound by the terms contained in this agreement.

Wedding Guest Guidelines

- No rice, bird seed or balloons are permitted. We suggest bubbles instead.
- Smoking and alcoholic beverages are prohibited in the garden.
- Parents or adults of children must stay with and monitor all children whom they bring to the wedding at all times.
- Please stay on paths to protect plant life.
- The Garden picnic area is available for groups smaller than ten. All other groups should call the Village to reserve the park pavilion at 815-423-5011.
- Pets, bicycles and skateboards are prohibited in the garden.
- Flowers and vegetables are for display purposes only. Please do not pick them.
- Clean up areas after use.
